Ballot Measure 114 Permanently Enjoined!

State Case - Harney County: Today Judge Raschio heard the 7 objections raised by the state's attorneys. ALL seven were denied and his legal opinion stands as written. This, from his opening of the hearing sums it up.

- "The Harney County Circuit Court is issuing a Permanent Injunction under Oregon Revised Statute 28.020 declaring 2022 Ballot Measure 114 unconstitutional thereby permanently enjoining its implementation. The court finds the plaintiffs have shown their rights to bear arms under Article I, § 27 of the Oregon Constitution would be unconstitutionally impaired if Ballot Measure 114 is allowed to be implemented. *Dovle v. City of Medford*, 356 Or. 336 (2014). Based upon a facial constitutional evaluation of Ballot Measure 114, the measure unduly burdens the plaintiffs' right to bear arms. *State v. Christian*, 354 Or. 22 (2013)."
