## ***Ballot Measure 114 Permanently Enjoined!***

### **Judge signs final order striking down voter-approved gun control law.**

PORTLAND, Ore. (AP) — An Oregon judge has entered the final order striking down a gun control law that was narrowly approved by voters in 2022. Harney County Circuit Court Judge Robert Raschio signed the general judgment on Monday. The judgment finalizes the opinion Raschio issued in November finding the law violated the right to bear arms under the Oregon Constitution.

The law, one of the toughest in the nation, was among the first gun restrictions to be passed after a major U.S. Supreme Court ruling last year changed the guidance judges are expected to follow when considering Second Amendment cases.
