Medford hosted the second match of the season. We had 18 competitors. It was a great match. Thorin Gaines (Grants Pass GP) won the Intermediate Junior Class with a 343 – 5 Centers. This Class shot three positions: prone, kneeling and standing. Elliot Owens (RSBG) won the Two-position Class with a 416 – 4 Centers. Josiah Eveland (RSBG) was second with a 414 – 4 Centers. Two points out of a possible 600 points separated 1<sup>st</sup> and 2<sup>nd</sup> . WOW, that is competition!!!! Two-position Class shoots prone and kneeling. Ryan McGinnis (RSBG) won the Beginner Over 11 Class with a 577 – 23 Centers. A third of his shots were Centers. His brother, Conner McGinnis, was second with a 526 – 7 Centers. Jedediyah Shelton (Med) won the Beginner 11 and Under Class with a 523 – 6 Centers. Fischer St Clair (GP) was second with a 457 – 3 Centers. ## Oregon Measure HP 4145

*HB 4145 is tied to Measure 114, which Oregon voters narrowly approved in 2022 to implement a firearm purchase permit requirement and magazine restrictions; the measure's legal status has been under court challenge and has delayed implementation.*

*HB 4145 is being debated during the 2026 legislative session as a way to address unresolved implementation issues and create a statutory framework for how the measure might operate.*

*This measure, if implemented will basically deter the purchase of firearms, substantially increase the cost of obtaining permits and increasing permit approvals to over 60 days.*

### **What HB 4145 Would Do**

HB 4145 proposes comprehensive changes to Oregon's firearm permitting and transfer rules tied to Measure 114. Key features include:

Modifying how and where people apply for a firearm purchase permit, including eligibility rules.

Extending the review period for permits from **30 days to 60 days**.

Allowing higher maximum fees for initial permits and renewals.

Setting **January 1, 2028** as the date when permits are required (delayed).

Creating exemptions **for active and retired law enforcement** from some permit and magazine restrictions.

Adjusting defenses related to large-capacity magazine provisions and procedural rules for legal challenges.

Declaring the bill effective immediately once signed.

### **Pros**

Supporters like the **League of Women Voters of Oregon** argue that these changes would clarify and improve the firearm permitting process, including: specifying application locations, clarifying eligibility, addressing training alternatives, and setting reasonable limits on fees. They believe this makes the overall system more efficient and implementable than the original Measure 114 framework.

**Enhances Enforcement and Safety Procedures** – Proponents see value in clarifying permit rules and background check procedures, which they say could lead to safer firearm transactions and more predictable administration by local and state agencies. This could particularly help in parts of Oregon with inconsistent practices across counties.

**Supports Public Safety Goals** – Those in favor of strong firearm regulation view these changes as a way to better close loopholes in current law and implement what voters approved in 2022 (Measure 114) — ultimately aiming to reduce firearm violence and ensure only qualified individuals can legally acquire guns.

**Cons:**

**Increases Barriers for Law-Abiding Gun Owners** – Critics — especially gun rights advocates — argue HB 4145 makes lawful gun ownership harder by raising permit fees from about \$65 up to \$150 or more and doubling how long permit approvals can take (60 days). They say this creates financial and administrative hurdles for individuals exercising their legal rights.

**Creates Unequal Treatment Under the Law** – A major point of contention is that active, off-duty, and retired law enforcement are carved out from some restrictions on permitting and large-capacity magazines, while civilians aren't. Opponents say this creates different classes of citizens with unequal access to firearms.

**Gives Discretionary Power with Potential for Abuse** – Some critics contend that extending permit review periods and granting significant discretion to issuing authorities could lead to subjective denials or inconsistent enforcement, rather than clear, objective standards.

## Summary

*Many opponents frame HB 4145 as legislatively overriding or expanding Measure 114 in ways Oregon voters did not approve — especially concerning costs, delays, and exemptions — and feel these changes should be subjected to voter referendum rather than legislative action.*
